- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

- 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25 % percentage of total quantity. # Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

#### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The prices are net including cartage loading, unloading, GST etc. and nothing extra shall be p ayable on any account.
- 2. Any tender with incomplete information or quotes is liable to be cancelled.
- 3. The quantities in the tender are approximate and may vary depending upon the actual require ment at the time of execution. However, any deviation, if required, shall be carried out only af ter instructions in writing from the faculty-in-Charge. The payment for such deviations shall be made or deducted at the contract rates.
- The material shall be of specified quality.
- 5. If the agency fails to provide the service to the satisfaction of the UNIVERSITY such as inferior quality of service, failing in providing the mentioned services in part or full in time, IGDTUW can impose suitable penalty and in such case decision of Vice Chancellor, IGDTUW shall be final and binding on the contractor.
- 6. In case, the service provider to whom the contract is awarded refuses to perform the contract ual obligations, the Performance Guarantee of such person shall be forfeited absolutely, and s uch person shall be blacklisted from participation in tenders at IGDTUW in future.
- 7. No tools and plants shall be issued by IGDTUW.

- 8. IGDTUW reserves the right to cancel the tender and service order in full or part before the dat e of start and no compensation shall be entertained in such circumstances.
- All the necessary safety precautions shall be taken by the service provider while providing se rvices.
- 10. The contractor shall indemnify IGDTUW against any accident causing any financial loss or injury and/or loss to the contractor or his workmen while providing the services.
- 11. The earnest money deposit of the successful bidder to whom the contract is awarded shall be converted into Performance Guarantee which shall be released only after successful completio n of services.
- 12. If any bidder withdraws his bid after submission of bid, the earnest money deposit of such bid
- der shall be forfeited absolutely.

  13. Besides above all terms & conditions of GeM GTC are also applicable for said Bid/BoQ The bid der must have the confirmed availability of the star artists whom the bidder proposes to arran ge from amongst a list of approved artists, while submitting the tender conveyed by such artis ts to the bidder.
- 14. Besides above all terms & conditions of GeM GTC are also applicable for said Bid/BoQ.

## **SPECIAL TERMS AND CONDITIONS**

- 1. Besides the contract amount, the service provider shall be entitled to raise sponsorship from t he corporate/government organizations. However, no sponsorship advertisement shall be allo wed from the manufacturers or traders of alcoholic liquor, tobacco and tobacco products, betti ng, gambling etc. at any cost. Besides this, IGDTUW reserves the right to enter sponsorship co ntracts separately for this event. The service provider providing event management service u nder this contract, therefore, shall **NOT** have exclusive rights to sponsorship.

  The whole event is meant for the IGDTUW students, faculty, officers, and staff of IGDTUW, or
- other guests invited by IGDTUW authorities only. The bidder can neither sell tickets nor issue passes to anyone and nor can he extend any sort of invitation to anyone whosoever for any of the events being organized at IGDTUW campus during the contract period.
- The erection of hoardings, banners, flexes etc. inside IGDTUW campus will be carried out in co nsultation with the Officer in Charge Estate Management, IGDTUW.
- The bidder is advised to visit the campus before quoting the rates to access the scope of work and site conditions.
- During two days of the festival expected footfall is 15,000 people with more than 5,000 people for Star Night.
- Neither direct advertisements nor proxy advertisements for any liquor or tobacco product or a ny other banned item shall be allowed inside the IGDTUW campus. Besides this, hoardings, ba nners, or flexes containing obscene contents shall not be allowed for display.
- The bidder shall have to remove all his material including advertisement on or before 27/02/2
- The bidder shall ensure that there is no loss or damage to any IGDTUW property due to any a ct of his. Loss, if any, shall be recovered from the event manager. The decision of the Vice Cha ncellor, IGDTÚW regarding the calculation of the amount of loss shall be final and binding on b oth the parties i.e., IGDTUW and the event manager.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
